- V. Discussion and Possible Action on Minutes of November 06, 2020 Meeting Presenter: Carolyn King, Chair
 <u>Upon motion by Board Member Ms. Jamie Allen the Committee unanimously</u> <u>approved the November 16, 2020 minutes</u>.
- VI. Discussion and Possible Action Nominating Slate of Officers (Chair, Vice-Chair, and Secretary) Presenter: Chair Carolyn King
 - Board member Jamie Allen proceeded to review the nomination slate of board members interested in being considered for WSA Board Officer positions.
 - Board members Ms. Leslie Cantu and Mr. Juan Solis representing the private sector category were on the nomination slate for WSA Board Chair.
 - Upon motion by Board Member Ms. Carolyn King and 2nd by Board Member Mr. Frank Crowder, the Committee unanimously approved the recommendation to nominate Mr. Juan Solis, III for WSA Board Chair.
 - Board members Ms. Leslie Cantu and Mr. Ben Peavy representing the private sector category were on the nomination slate for WSA Board Vice Chair.
 - <u>Upon motion by Board Member Mr. Frank Crowder and 2nd by Board Member</u> Jamie Allen the Committee unanimously approved the recommendation to nominate Leslie Cantu WSA Board Vice Chair.

- Board member Mr. John Blaylock representing the private sector category were on the nomination slate for WSA Board Secretary.
- Mr. Adrian Lopez, CEO informed the Nomination Committee, that Mr. John Blaylock had not submitted his WSA board application, and he stated he was re-locating out of the region.
- Mr. Frank Burney recommended the committee nominate Mr. Ben Peavy and Chair King would reach out to him and see if he is interested in the Secretary position.
- Upon motion by Board Member Ms. Jamie Allen and 2nd by Board Member Mr. Frank Crowder the Committee unanimously approved the recommendation to nominate Mr. Ben Peavy WSA Board Secretary.
- VII. Discussion and Possible Action on Recommendations of Changes in Board Membership Based on Attendance Presenter: Chair Carolyn King
 - Mr. Frank Burney and Mr. Lopez discussed the Board attendance in which WSA Board members are required to attend 75% of meetings. The policy did not consider the attendance to committee meetings. It was also discussed that due to the pandemic and the current situation, all WSA Board Members would be allowed a "pass".
 - Mr. Lopez also discussed with the Committee the option to update the current policy to include attendance to committee meetings.
 - Mr. Frank Burney recommended allowing all board members a COVID "pass" and updating the current policy to include attendance to committee meetings and board meetings.

Upon motion by Board Member Ms. Jamie Allen and 2nd by Board Member Mr. Frank Crowder the Committee unanimously approved the recommendation to nominate Mr. Ben Peavy WSA Board Secretary. Chair King will follow-up with Mr. Peavy to confirm his acceptance of nomination as WSA Board Secretary. In the event he does not accept, the Nominations Committee will accept a floor nomination from the Board at the December board meeting.

- The officers of the Organization shall be a Chair, a Vice Chair, and a Secretary
- Officers of the Organization shall be elected by the Board to a one (1) calendar year term, or until their successors are elected, and shall be eligible for re-election without limitation.
- The Board shall elect its officers from the nominations slate and from any nominations from the floor for each office, at the annual meeting of the Board.



The Chairperson shall be elected by the Board from among those directors who are representatives of the private sector. The duties of the Chair shall include but are not limited to the following:

- Preside over meetings of the Board;
- Make appointments to standing committees, Ad Hoc committees and shall be an ex-officio member of all committees;
- Serve as the official spokesperson for the Board;
- The Chair or a designee shall represent the Board at state, regional or national meetings concerning workforce development or other business of the Board; and
- Except as otherwise provided by Board policies, Applicable Law or in these Bylaws, the Chair, in the name of the Board, shall execute contracts, plans or other instruments authorized by the Board.



The duties of the Vice Chair shall include, but are not limited to:

- In the Chair's absence or temporary disability, the Vice-Chair will exercise all authority and discharge all responsibilities of the Chair subject to restrictions applicable to the Chair;
- Perform such other duties as may be identified by the Board.



The duties of the Secretary, which may be the Chief Executive Officer, shall include, but are not limited to:

- Keep or cause to be kept, and certify the minutes of all meetings of the Board;
- Serve as custodian of corporate records; and
- Perform all duties incident to the office of the Secretary as may be required by law, these Bylaws, or as assigned from time to time by the Board.

OVERVIEW OF ELECTION PROCESS/PROCEDURE AT BOARD MEETING

ELECTION OF OFFICERS

- 1. Call for the nomination report for Chair;
- 2. Then Chair will open the floor for nominations for any other candidates for Chair;
- 3. Once all nominations are made, Chair will close nominations;
- 4. If voting by ballot is requested (rather than vote by hands), each Board member will have to write out his or her vote with their name of the ballot;
- 5. Ballot will be tallied, and results announced;

The Chair then would proceed with elections of other officers. If there is only one nominee for other positions (Vice-Chair and Secretary), the Chair should entertain a motion to elect such persons by acclamation. If contested, repeat process above.

Both candidates for Chair and the Vice-Chair must be from the private sector.

HANDLING NOMINATIONS FROM THE FLOOR

After each nomination, the chair repeats the name as having been nominated. For

example, he may say, "Cletus Potzbius has been nominated. Are there further

nominations?"

The process of making floor nominations is subject to the following rules:

- Recognition by the chair isn't required to make a nomination. A member may call out a nomination while remaining seated. However, in larger organizations, calling nominations from your seat is usually impractical. In such cases, members may adopt a more formal nomination process either by rule or by the adoption of an incidental motion for that particular meeting or election.
- Nominations don't have to be seconded, but it's not out of order for members to second a nomination to signal their endorsements.
- A member shouldn't offer more than one nomination to a position if there are several seats for the same office — such as for nominees to a board or a committee — until all other members have had the opportunity to make nominations. However, if a member does make more nominations before others have had their chance, his additional nominations aren't out of order unless someone objects to his actions. Additionally, it is not in order under any circumstances for a member to nominate more persons than there are seats

available. For example, if an election is to fill three seats on a board, a member cannot nominate four people.

• Nominations are taken for successive offices in the order the bylaws list them.
