Presenter: Jennifer Benavides, District Director of P-TECH Programs & Alamo Academies, High School Programs, Alamo Colleges District

Jennifer Benavides highlighted the importance of integrating Career and Technical Education (CTE) into P-Tech programs. P-TECH Programs and CTE

VII. IN-PERSON YOUTH SUCCESS STORY

a. Youth Participant, Jesus Cardenas

Jesus Cardenas, a parenting youth with a criminal background, moved from Laredo to San Antonio seeking better opportunities. He joined the YES! Program in October 2022 and completed Web Development training at UTSA. In August 2023, he enrolled at Northwest Vista College to pursue Philosophy, aiming for law school. With support from his Career Navigator, he now works as a Paralegal Assistant earning \$18/hour, volunteers at The Oasis Center, and maintains a 4.0 GPA while raising a family and working two part-time jobs—set to graduate with an associate's in business in May.

a. Youth Program Briefing and Performance

For Program Year 2025, Workforce Solutions Alamo continues partnering with SERCO to support youth enrollments and workforce training. WSA works closely with SERCO to meet Texas Workforce Commission goals and stay within budget.

b. Career Exploration Events

As outlined in the WCI Grant, WSA will use TANF funds to host Jobs Y'all career exploration events for students, engaging employers to showcase in-demand careers and hands-on opportunities. Parents will be encouraged to participate. In FY2025, WSA plans four major events, with more co-hosted opportunities under discussion. Upcoming career exploration events include a Fiesta event and a World of Work event.

c. Youth Model Update

WSA's Career POP Youth Service Delivery Model, highlighting key milestones from May to October 2025. The focus is on refining and implementing the model through stakeholder input, school pilot selection, and community integration.

IX. CEO REPORT

a. The Alamo City Electrathon (ACE) RACE

Mr. Adrian Lopez, Chief Executive Officer of Workforce Solutions Alamo, provided updates on the ACE Race initiative. He shared a presentation on the ACE Race Car Decals and reported that the upcoming ACE Race, sponsored by South Texas Business Partners, has set a new participation record—with 35 schools and 49 cars registered for the event. The ACE Race will take place on Saturday, April 12, 2025, at the San Antonio Police Academy.

X. CHAIR REPORT

a. Youth Committee Member Updates

Mr. Anthony Magaro, Youth Committee Chair, opened the meeting by welcoming two new board members who recently joined the committee and invited them to introduce themselves to the group. Mr. Magaro emphasized the critical role of employer engagement in the success of Career and Technical Education (CTE) initiatives. He stated, "The employers—I see it in the numbers. We must act both individually and corporately to strengthen our presence in CTE. It should have been more robust, and it won't succeed without a true commitment from employers. He encouraged WSA and its partners to remain actively involved and to bring others into the conversation, especially as they attend various events. Mr. Magaro also shared that one of WSA's key partners, SA Works/Greater SA, is opening up positions, and many students are actively applying for summer employment opportunities. He concluded by inviting any comments, questions, or concerns from the committee and expressed his appreciation to all partners and participants for their continued engagement and attendance.
